

## Welsh Judo Association Board of Directors Nomination Form

### Guidelines for nominations

- 1 Nominations must be submitted on the form below to the chairman of the board **by 16<sup>th</sup> May 2014.**
- 2 Nominations must be signed by the nominee to indicate agreement to the nomination.
- 3 Nominations must be submitted with accompanying letters of support from 2 other clubs.

### Guidelines for nominees

- 1 The information you provide should reflect your skills and experience in terms of the set criteria:
  - ability to effectively represent Welsh Judo members as a member of the Board of Directors
  - fundamental understanding of Welsh judo
  - proven track record of strategic decision making
  - proven track record of working with other Welsh member clubs and regions
  - affiliated to a registered WJA club/region
  - current WJA licence holder
  - must reside within Wales
- 2 Proof of qualifications must be provided if this information is to be included in election material
- 3 Members of the WJA board of directors should expect you to contribute to the management of the affairs of the Welsh Judo Association at a strategic level.
- 4 Nominees' attention is drawn to the documents "the duties of directors: notes of guidance", the Welsh Judo Association – "equal opportunities policy" and "Safeguarding policy" all of which are available on the WJA website.
- 5 Only 1 nominated candidate per club, with supporting referees only supporting 1 nominee.
- 6 Please note: as the role of director involves decision making which affects safeguarding policies and procedures of the association a BJA enhanced DBS check will be required to be completed by the elected candidate if not already completed.

### Nominees - please note:

You are very welcome to prepare your own election manifesto. This can be a statement, promotional flyer, CV, in colour or black/white, whatever you would like and whatever can fit onto one side of A4 (not double sided or a5). You will be required to provide 8 copies to be received at the WJA head office by 12.00 midday on Friday, 16th May 2014.
